TECHSOLV-GP-LVP DEGREASER

TECHSOLV-GP-LVP (Low Vapor Pressure) is a degreasing solvent engineered to be a high strength cleaner which performs well in most industrial applications. It has a VOC content of less than 25 grams per liter.

TECHSOLV-GP-LVP will evaporate in 10 to 20 minutes when wiped or blown to a thin film. In open containers, its evaporation rate is slightly slower than water. This means that less solvent is used in normal degreasing operations which leads to significant dollar savings annually.

TECHSOLV-GP-LVP will partially mix with water and is water rinseable.

TECHSOLV-GP-LVP has a Tag Closed Cup flash point of $>185^{\circ}\text{F}$ [per ASTM-D56], giving it an OSHA classification of combustible class III.

In containers of less than 119 gallons, it is not regulated by the DOT. It is classified as not hazardous by SARA Title III, Sections 311, 312, or 313. It is listed under TSCA.

TECHSOLV-GP-LVP has been evaluated and determined to meet the Low Vapor Pressure [LVP] exemption set by the California Air Resources Board [CARB] for volatile organic compounds in consumer products [California Code of Regulations, Title 17, Article 2, Section 94510]. Its vapor pressure mmHg is less than 0.1 at 68°F .

TECHSOLV-GP-LVP is non-corrosive to metals such as copper, aluminum, brass, magnesium, and steel. The product conforms to the requirements of ASTM F945 [stress crack corrosion of titanium alloys] and ARP 1755A [stock loss corrosion] tests.

TECHSOLV-GP-LVP has a recommended Occupational Exposure Limit [OEL], TWA, of 300 ppm. It has a very slight citrus odor. It contains no CFCs or HCFCs.

TECHSOLV-GP-LVP is available in packaging that meets most industrial situations.
